Kelly Piacenti leads the MassMutual Special *Care* program which encompasses a network of nearly four hundred Special Care Planners<sup>1</sup>. She also manages strategic partnerships between MassMutual and national non-profit organizations serving the special needs community; including, but not limited to: The Arc, Autism Society, Huntington's Disease Society of America (HDSA), National Down Syndrome Congress (NDSC), Tuberous Sclerosis Alliance, and United Cerebral Palsy (UCP).

Kelly currently serves on the National Board of Directors for UCP and previously served on the National Board of The Arc for 8 years, concluding her term in 2020. She is also a member of the Advisory Board for both The Academy of Special Needs Planners and The American

College Center for Special Needs. Additionally, she formerly held the role of Chair for MassMutual's ADAPT Business Resource Group, which is dedicated to promoting inclusion and better serving the disability community.

Kelly has presented at numerous industry conferences across the country, such as LIMRA Advanced Sales Forum, Disability:IN Global Conference, etc. and has been a featured guest on various radio talk shows and podcasts. Her insights have also been published and quoted in a wide range of industry publications focused on the special needs community, i.e. Exceptional Parent Magazine, U.S. News World Report, ConnectCom, etc. In April 2024, United Cerebral Palsy honored her with their annual Chair Award, recognizing individuals who have demonstrated exceptional volunteer leadership and support for UCP's mission and vision. In May 2017, Kelly received the Theresa Award from the Theresa Foundation for her outstanding community service and advocacy for individuals with special needs. Additionally, in fall 2015, Working Mother magazine named Kelly as a "Working Mother of the Year" in its "100 Best Companies" feature.
